PREREQUISITES

Basic Prerequisites

- An understanding of report writing is desirable.
- **The students are expected to have acquired the following prior knowledge:**

Knowledge of the following environmental management principles and concepts and the intended outcome of an environmental management system

- Enhanced environmental performance
- Fulfilment of compliance obligations
- Achievement of environmental objectives

Knowledge of the requirements of ISO 14001, which may be gained by completing a CQI-IRCA certified EMS Foundation Training course or equivalent. Further, the delegates must also be aware of Generic management systems including the PDCA cycle and interrelationships between core elements of a Management System and Top Management, Policy, objectives, planning, implementation, review and continuous improvement.

Specific Prerequisites

This course is meant for qualification of existing auditors of other management system disciplines (E.g. QMS, OHSMS, FSMS, ISMS, EnMS, etc.). Knowledge of management systems audit as per ISO 19011 is required through the satisfactory completion of a CQI-IRCA Certified Auditor/Lead Auditor Training course in another discipline or an acceptable alternative (Please contact us for Details).

CONTENTS



There is a 100-minute long examination for this course. Electronic devices, including laptops and mobile phones, are not permitted into the examination room. Delegates will also be assessed on the basis of their progress throughout the exercises.

Delegates who successfully complete both the examination and the continuous assessment will be awarded a certificate of Successful Completion and will satisfy the formal training requirements for the CQI-IRCA EMS Auditor Certification scheme. Other delegates will receive a certificate of attendance and such delegates will not be accepted by a certification body or for CQI-IRCA registration.

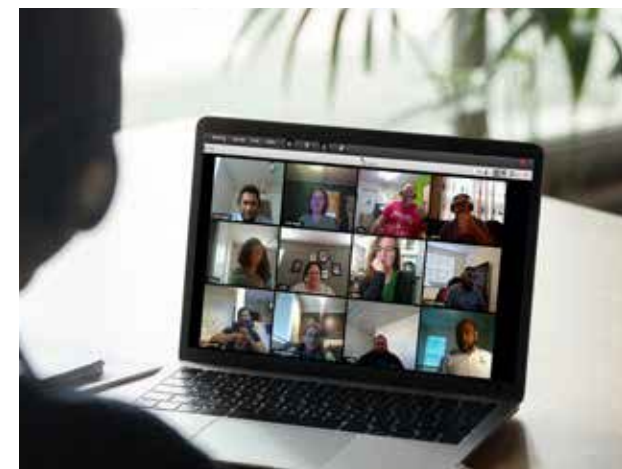
